VI. AOC Report (Jane Siling)

- 01.17.2024 - Tampa Police Department (One on Ones - 3); A domestic dispute broke out with a mentally unstable male, his mother, his daughter, and a female family friend. The male grabbed a firearm and shot all 3 females, with one being a fatal headshot to the family friend. When officers arrived, the male's mother and daughter were standing outside, both with gunshot wounds. As officers approached, the male exited the house briefly and fired 2 shots at an officer. The officer returned fire and the male fled into the house. Officers were advised there was a third victim inside and the decision was made to make entry using shields. Once contact was made with the male, he gave up and

was placed under arrest. The third victim was then located and suffered a fatal gunshot wound. No officers were injured. [#560]

- 02.13.2024 - Pasco Emergency Communications (One on One - 1); Call taker received a call from a young female who was having a difficult time at home with her parents and had been feeling like she wasn't o'k and wanted to hurt herself. The call taker remained on the line upon deputies arrived. Call taker was emotionally stressed due to the females young age and her situation at the home. Call taker also had handled many high priority calls recently. [#561]
- 03.06.2024 - Tampa Police Department (One on Ones - 2); On March 4, 2024, officers responded to a shot spotter activation and while enroute were advised 2 subjects had been shot. Upon arrival, officers encountered a crowd and 1 subject with head trauma. The second subject was subsequently located with upper body trauma. Both officers rendered aid to the subject with head trauma while dealing with an upset crowd that had surrounded the officers. The subject later died at the hospital. [#562]
- 03.05.2024 - Tampa Police Department (One on Ones - 2); On March 4, 2024, officers responded to the area of 3401 E. Hillsborough Ave reference a male waving a firearm and threatening to shoot people and officers. As officers responded to the area, the male pointed the firearm at 2 officers placing them infer of being shot. The subject was eventually taken into custody without further incident. [#563]
